

Privacy Policy

R. Hamilton & Co Ltd, (Hamilton Litestat) takes the confidentiality of your personal data very seriously. We are committed to safeguarding the privacy of our website visitors always, and this privacy policy details how we will treat your personal data.

The new GDPR (General Data Protection Regulation) legislation has now come into effect (25th May 2018) across the UK and EU. Companies who store personal information about individuals are obliged by law to inform their customers, suppliers and business contacts that they are storing the information and the reasons why.

We, at Hamilton, are transparent about the information that we store, the purpose for storing it and how it is used. Hamilton is committed to protecting and respecting your privacy and stores the following information and the reasons why:

The information we collect

- We store and use your name, telephone number and email address to contact you concerning Purchase Orders, Order Queries, Deliveries, Invoices, Payments & Product Enquiries.
- 2. As a visitor to the Company website, we may also collect information about your computer and your visits to and use of our website including: IP address details, geographical location, industry sector, browser type, referral source, length of visit and number of page views.
- 3. You may also be asked to provide us with personal information on various occasions. This could be, for example, to request information from the Company, to take part in competitions, to become a member in a customer club, to request/order product samples. The type of information we collect for these purposes is typically your name, company address, telephone number and e-mail address, and sometimes even your personal identification number.

How is information used?

The information we collect is used for the following purposes:

- to be able to offer safe and simple use of our website
- to be able to communicate with you in connection with competitions, training events, and other interactive offers
- to be able to provide you with information about the Company and our services
- to be able to offer you marketing and advertisements which we think you will find interesting

Which information must you provide?

On every occasion you are requested to provide personal information, it will be clear when the information is required for a service and when it is purely voluntary to provide it.



Cookies & IP-addresses

To be able to offer information and solutions which are tailor-made and adapted to users of our website, we sometimes use cookies to store and search for information about you. A cookie is a small amount of data which is sent to a web reader from a web server and which is stored on the hard disk of your computer.

Cookies are commonly used to:

- Identify your computer
- Count the number of users to different websites
- Trace the interest in certain offer, clubs and competitions
- Measure traffic patterns on websites

Cookies are not used to collect information about visitors' names or email addresses.

Modifying your browser settings

You can modify your browser settings at any time, including setting your browser to notify you when you receive a cookie, giving you the choice to decide whether or not to accept it. If you reject cookies, you may still use our sites, but functionality of some areas may be limited.

Who has access to my personal information?
